

TERMS OF USE

1. Identification of the Owner

Ares Lusitani – STC, S.A., a company incorporated under the laws of Portugal, with its registered office at Edifício Colombo, Torre Oriente, Avenida do Colégio Militar, with a share capital of EUR 250,000.00 (two hundred and fifty thousand euros), registered with the Commercial Registry Office under the sole registration and legal entity number 514657790 (“Ares Lusitani”), is the owner and administrator of the website www.areslusitani.pt (the “Website”).
